The mission of the VFZ is to identify organizations that are centers of positive influence for their communities and strengthen their operations through training, technical assistance and linkages of support so that they can work to end violence and revitalize communities. CNE has taken this model and partnering with strong youth-serving organizations, implemented programs around the country. The VFZ currently focuses on the most troubled public schools and neighborhoods in Milwaukee, Racine, and Baltimore in an effort to stop the soaring incidence
